The Ohio Board of Pharmacy has outlined specific requirements as it relates to the management of biologicals or vaccines administered to individuals for the purpose of preventing diseases. Examples of these products include influenza vaccine, tetanus toxoids, hepatitis B vaccines, PPD or TB tests. For a Skilled Nursing or Assisted Living Facility to procure these vaccines and biologicals for residents and staff on a bulk stock basis, there must be a TDDD (Terminal Distributor of Dangerous Drugs) license to which the prescription drug stock is transferred to.

- If the SNF facility already has a Contingency Supply TDDD license, then this TDDD license will
 cover the stock of vaccine or biological for residents only. No additional action is required to
 continue with resident vaccinations.
- If a SNF facility chooses to maintain stock of vaccines or biologicals for staff/employees/family
 members, then a separate *Limited Category 2 TDDD* license must be obtained by the facility
 from the Ohio Board of Pharmacy. This is a separate requirement, even if a Contingency Supply
 TDDD is already available on site at the facility.
- For Assisted Living Communities, the same requirements apply for Residents and Staff. If the
 facility does not hold a Contingency Supply TDDD, then a separate *Limited Category 2 TDDD*license would be required; in this case the same *Limited Category 2 TDDD* license would be used
 for both resident and staff/employees/family vaccine stocks. Alternatively, the residents and
 staff can be vaccinated by their personal health-care provider, or local retail pharmacy.

 - Drug List- Limited Terminal Distributor License Form- the list of specific items for facility stock
 - Standing Orders/Protocol for Drug Stock Items on your list
 - o Attestations from Applicant and Responsible Person
- Effective 8-5-19, the Responsible Person for a Terminal Facility Limited Category 2 License is only a DO, MD, or advanced practice nurse (APRN). Information needed for Responsible Person is the following:
 - o Name
 - o Title
 - o Date of Birth
 - Social Security Number
 - License Number
 - Email Address

- Customize and complete the *Drug List-Limited Terminal Distributor License form*; the sample form provides a sample list of items- delete any unnecessary items.
 - For facilities that currently have a medical oxygen license, please ensure that you include Oxygen on this new Drug Stock List, along with the vaccines you will stock.

- A Standing Order or Protocol is required for <u>each</u> medication on the Drug Stock list. This
 document does not need to be notarized per the Ohio State Board of Pharmacy. You do not
 need to include a protocol for medical oxygen.
- Submit the for Terminal Facility Limited Category 2 License application, and include the Drug List form, Personnel List, and Standing Orders via the elicense system.
