### Register Your Facility:

1. Go to [Facility Registration](#) to register your facility with ODH.
2. Wait to receive an email notifying you that your facility is approved.

### Add or Update Facility Visitation Hours

1. Go to [ohid.ohio.gov](http://ohid.ohio.gov) and login.
2. Navigate to the **Sites & Applications** tab.
3. In the app carousel at the top of the screen, find the **LTC Facility Visitation** app and click to launch it.
4. Follow the prompts to enter your visitation information. Repeat these steps to make edits or updates, as needed.
