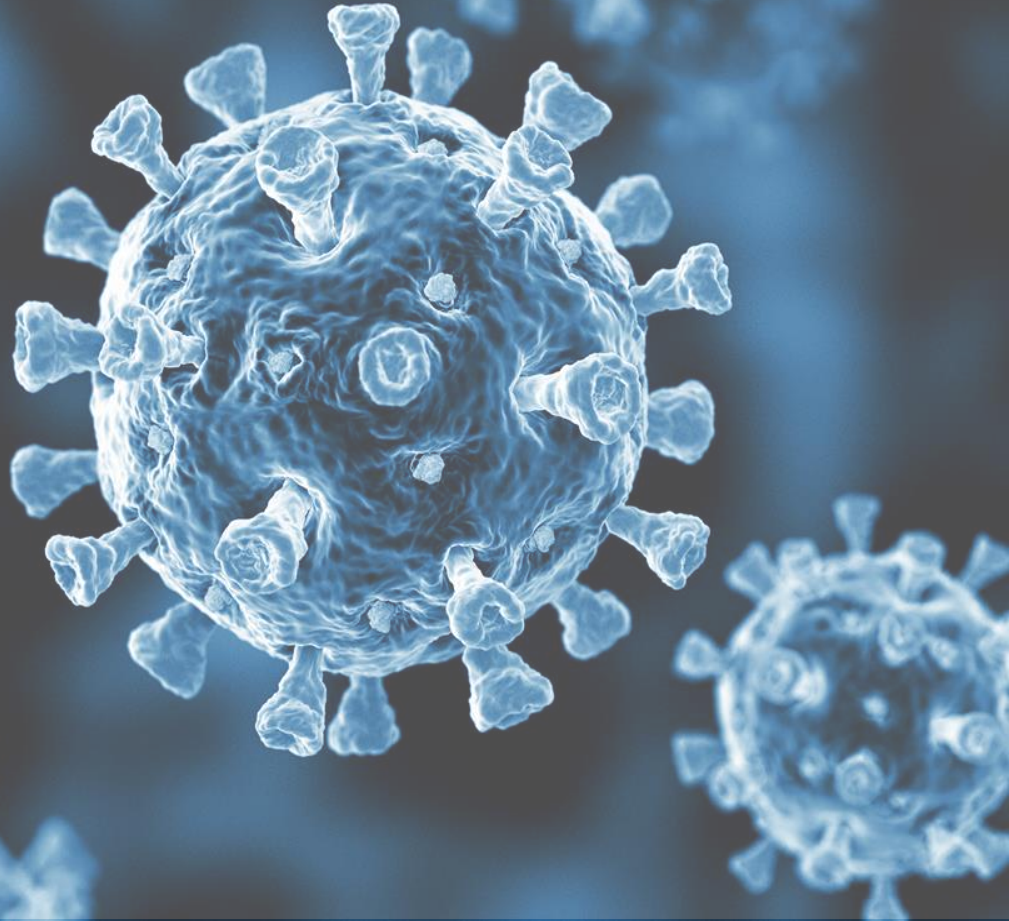

FDA Emergency Use Authorization granted for Pfizer/BioNTech Vaccine.

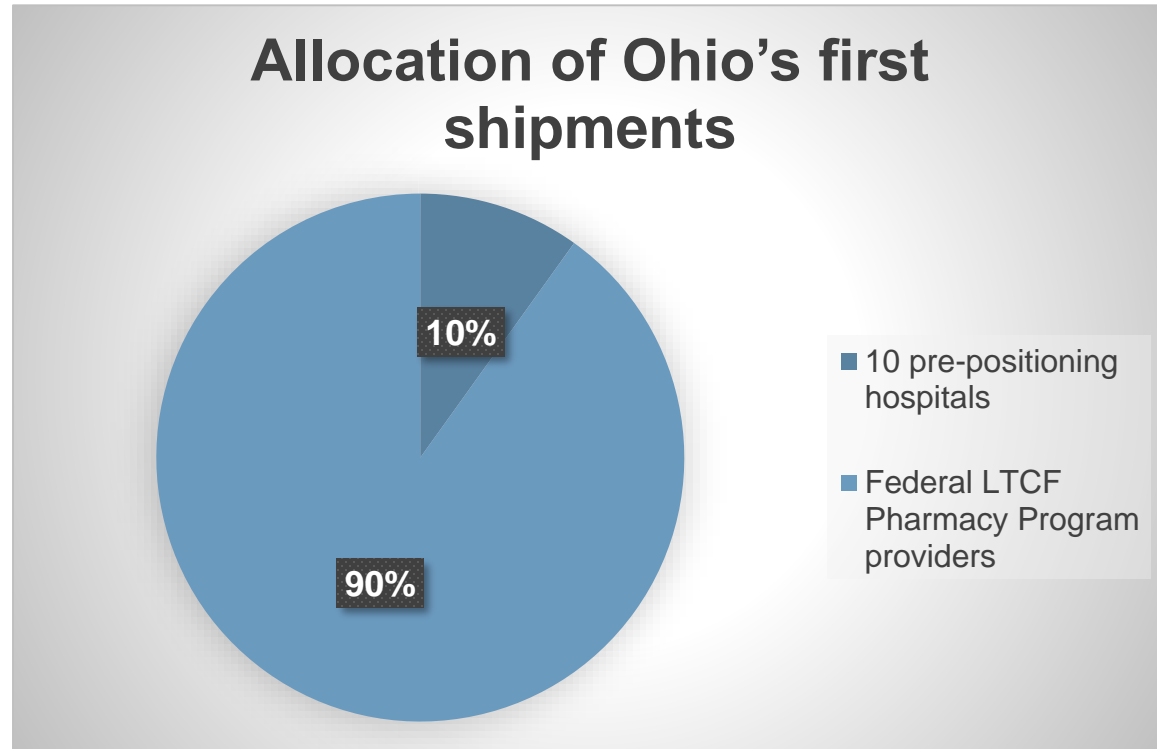
## CDC Action

**Sunday, Dec. 13**

Director Robert Redfield signed off on Advisory Committee on Immunization Practices recommendation for use of Pfizer/BioNTech vaccine in individuals age 16 and older.

# First vaccine shipments arrive in Ohio

98,475 doses of Pfizer/BioNTech vaccine were shipped to Ohio Monday and Tuesday for long-term care facilities and frontline healthcare workers.



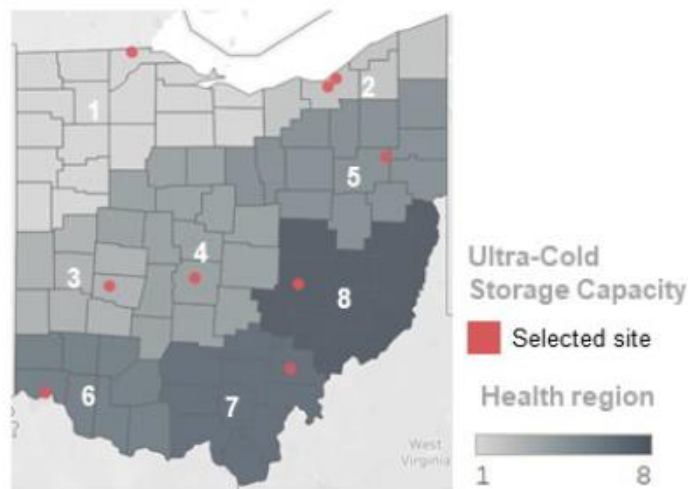
# Healthcare staff get the first vaccines

Ten pre-positioning hospitals in Ohio received 975 doses each on Monday and Tuesday, and immediately began to vaccinate some of their staff who are routinely involved with the care of COVID-19 patients.



# Ohio COVID-19 Vaccine Pre-Positioning Hospitals

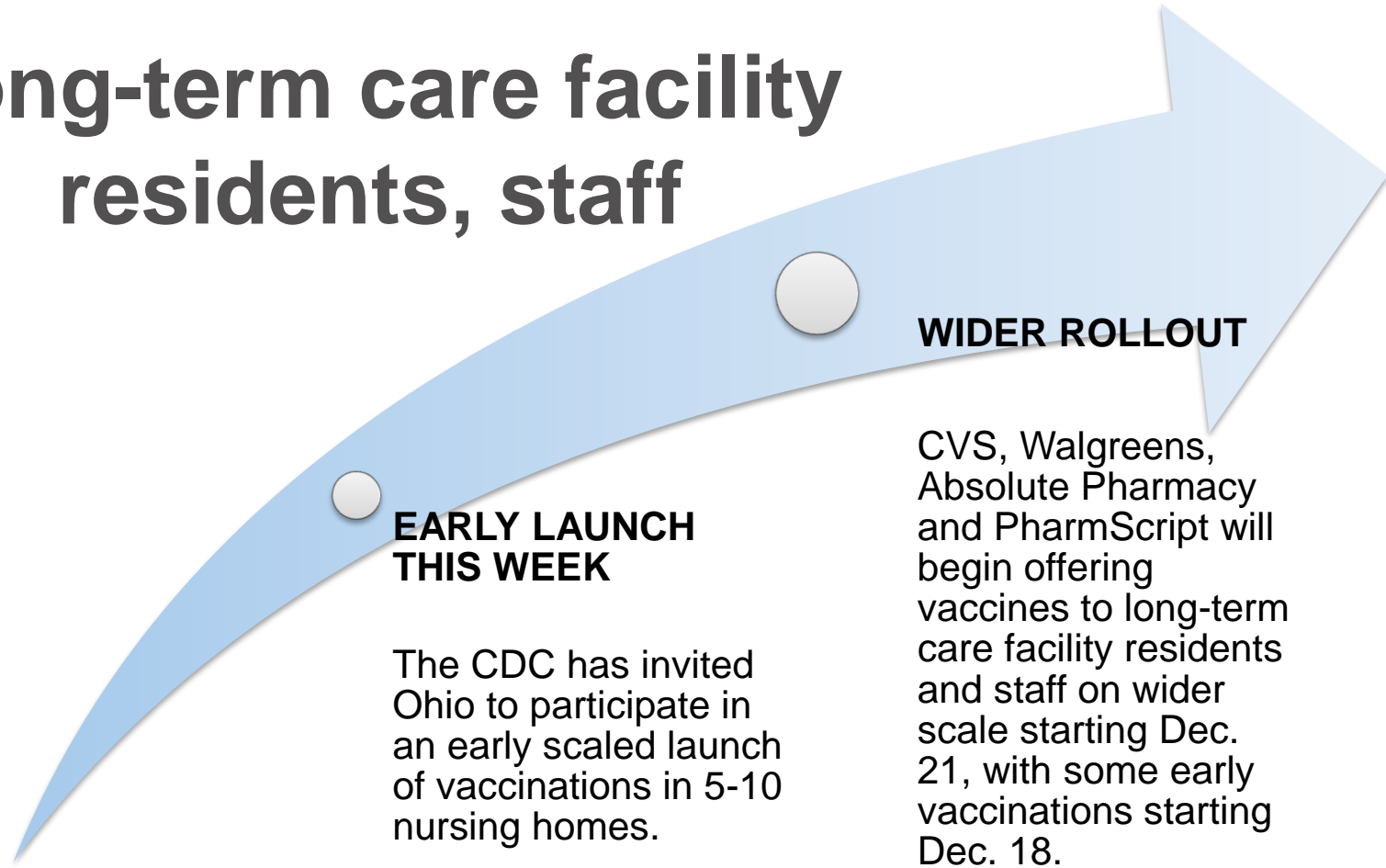

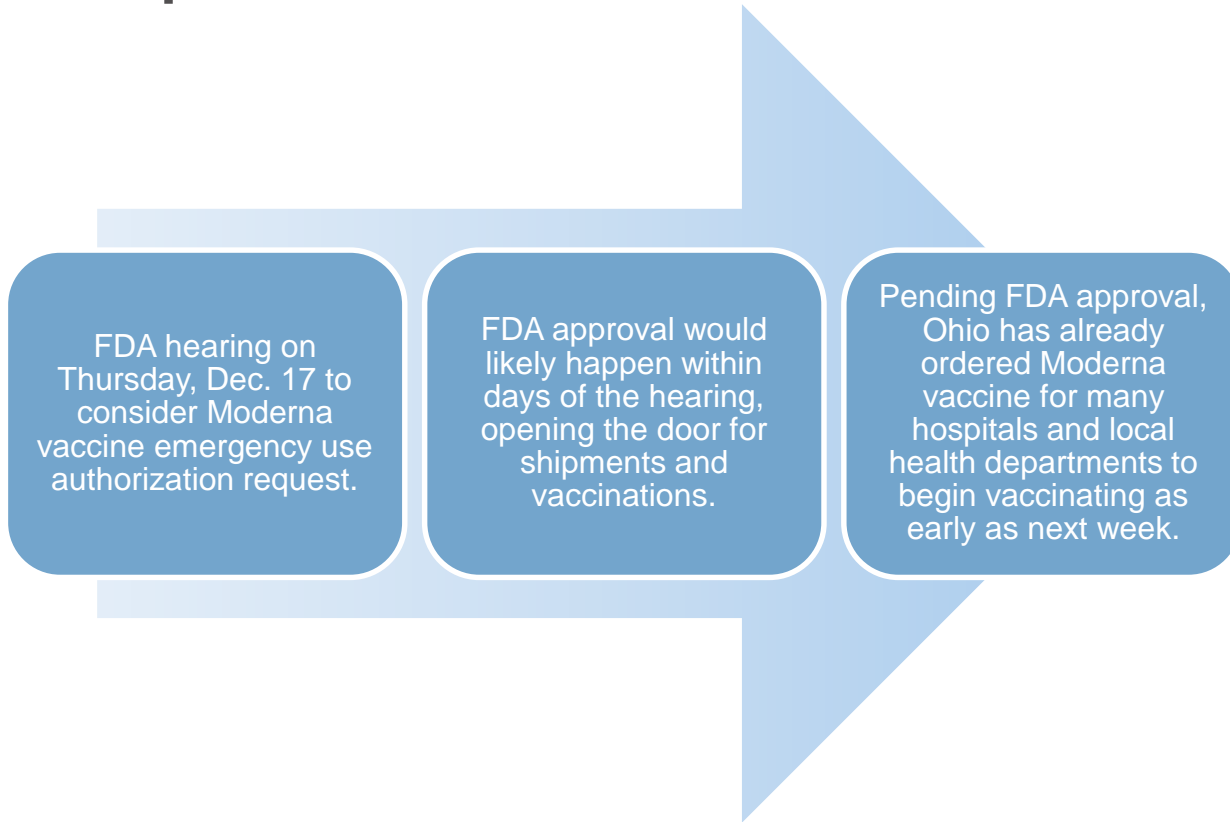

# Ohio's Vaccination Program

## – *A Phased Approach*

### GOALS

Save lives and slow the spread of the virus.

In the early vaccination phase, supply will be limited. The speed at which Ohio will move through the phases is largely dependent upon the number of vaccine doses available.

#### PHASE 1



### Supply Limited

Vaccine is available in limited supply for specific critical populations. Ohio will focus on vaccinating those most at risk, as well essential healthcare workers and personnel caring for COVID-19 patients. Vaccines will not yet be available for all Ohioans.

#### PHASE 2



### Supply Increasing

Vaccine is increasing and available for other specific critical populations who choose to be vaccinated. Vaccines will not yet be available for all Ohioans.

#### PHASE 3 - 4



### Widely Available

Once the vaccine is widely available, Ohio will continue to strategically vaccinate Ohioans if they choose. During these phases, vaccines will begin to be available to all Ohioans.

*As supply increases, COVID-19 vaccines will be available to all Ohioans who choose to be vaccinated.*

### **PHASE 1A**



- 
- Health care workers and personnel, who are routinely involved with the care of COVID-19 patients
  - Residents and staff at nursing homes
  - Residents and staff at assisted living facilities
  - Patients and staff at state psychiatric hospitals
  - People with developmental disabilities and those with mental health disorders, including substance use disorders, who live in group homes, residential facilities, or centers and staff at those locations
  - Residents and staff at our Ohio veterans homes
  - EMS responders

*All available vaccines will be administered to those who **choose** to receive it.*

# Next steps: Local health departments to help vaccinate critical healthcare workers

Home health/hospice workers not vaccinated by hospitals or healthcare systems.

Emergency Medical Services responders.

Primary care practitioners, including family medicine and general medicine providers.

Freestanding EDs, urgent care, pharmacies, and dialysis centers not vaccinated by hospitals or healthcare systems.

OB-GYN practitioners not vaccinated by hospitals or healthcare systems.

Federally Qualified Health Center providers.

Dental providers.

Surgeons not vaccinated by hospitals or healthcare systems.

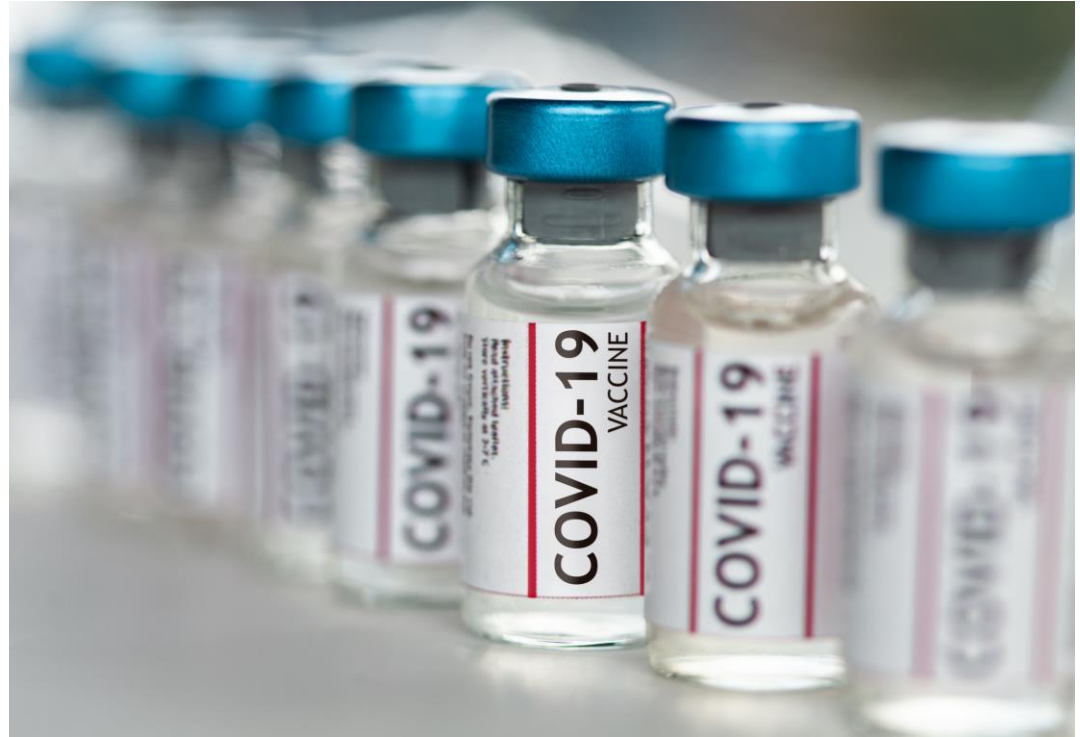
Mobile unit practitioners.

Healthcare providers, including public health employees, at risk for exposure such as vaccinators.

High-risk ancillary healthcare staff (for example, but not limited to, transport and janitorial support staff).

# Vaccine provider enrollment update

- Currently, about 764 providers have enrolled in Ohio's COVID-19 Vaccination Program.
- When we send you COVID-19 vaccination information, please share it with your members and encourage them to enroll.



# REMINDER: How to enroll as provider

- Ohio has established a network of enrolled providers to administer the vaccine. Register at <https://ohid.ohio.gov>.
- Enrollment is still open.
- We will provide access to training and support to enrolled providers.
- Ultra-cold storage is not a requirement to enroll.
