<input type="checkbox"/> July 13, 2022	Reporting Requirements <i>This session will review the reporting requirements for nursing homes. F-884 continues to be the top cited F-tag. Facilities are required to do COVID-19 reporting to the CDC, residents, their representatives, and families. The session will cover how noncompliance results in citations. ODH updates and current citation trends in Ohio will be discussed.</i>
<input type="checkbox"/> August 10, 2022	Infection and Prevention Control <i>This session will include review of infection control specific citations from annual surveys. Infection control citations consist of both COVID-19 practices and noncompliance with standard infection control practices. State survey agencies must continue to perform annual focused infection control surveys of 20% of nursing homes. States are to prioritize these surveys for facilities that are reporting new cases and have low vaccination rates. How infection control noncompliance results in citations will be discussed. Regulatory language and recommended standards of practice for infection control and review of CDC recommendations will be given. CMS and CDC resources and training opportunities will be shared.</i>
<input type="checkbox"/> September 14, 2022	Skin Integrity and Pressure Injury <i>This session will include review of skin integrity and pressure injury citations. Top cited areas will be discussed with citation examples given. How noncompliance results in citations will also be discussed. Regulatory language and recommended standards of practice will be shared as well as monitoring standards.</i>
