

	July 12, 2023	Transfers and Discharges Facility-initiated transfer and discharges is a top complaint filed with the State Ombudsman's office and is frequently cited by the Ohio Department of Health. This session will include a review of the trends in transfer and discharge citations. Regulatory language related to transfers and discharges will be shared. Best practices in meeting the notification requirements will be discussed.
	August 9, 2023	Sufficient Staffing Staffing has become a focus at the State and National level. This session will include information on the most recent mandatory staffing updates. The CMS surveyor's guidance in determining non-compliance with staffing standards will be explained. ODH updates and current citation trends in Ohio will be discussed.
	September 13, 2023	Pre-admission Screening and Resident Review Mental health disorders, in particular Schizophrenia diagnoses, is now part of a targeted CMS survey. The pre-admission screening and resident review (PASARR) process is a key component of meeting regulatory requirements for residents with serious mental disorders. This session will review the compliance requirements for the PASARR process. ODH trends in citations will be discussed.
