Talking points for policymakers, stakeholders

- This was not frivolous action.
 - LeadingAge Ohio has not sued the Department in recent memory (ever?)
 - Ohio's nursing homes, via their associations, did not take this action lightly. Rather, we exhausted all other avenues (legislative, administrative) before resorting to this action.
- Yes, it is a lot of funding. That's why we couldn't ignore it.
 - The amount in question is of profound consequence to nursing homes, which have continued to operate without necessary funding for over two + years since the budget's passage.
- Yes, it is messy. That's why we tried so hard to remedy without legal action.
- Ohio's nursing homes still need restoration: Ohio's average nursing home Medicaid margin is (\$60) per resident, per day, a level of losses 50 percent higher than what it was pre-pandemic.
